AFTRCC NO LONGER COORDINATES 2305.0 OR 2345.0 MHZ ON A SECONDARY BASIS DUE TO NATIONWIDE ROLLOUT OF CELLULAR LTE SERVICES AS WOULD CAUSE INTERFERENCE TO SAME INCLUDING THE CLEVELAND METRO AREA.

AFTRCC DATABASE CHECK CONFIRMS NO CONFLICTING ASSIGNMENTS WITHIN 30 MILE RADIUS OF REQUESTED LOCATION/DATES.
