3G Wireless, LLC hereby requests Special Temporary Authority (STA) to operate at 2267MHz and 2287MHz pursuant to Section 21.25 of the Commission's Rules. 3G Wireless, LLC requests that the Commission grant it temporary authority to operate on the frequencies centered at 2267MHz and 2287MHz with a 16 MHz bandwidth from April 05, 2015 through September 05, 2015 with intermittent usage. As explained below, 3G Wireless, LLC is filing an STA request to provide two RF camera systems to various baseball stadiums throughout the country during the Major League Baseball season. 3G Wireless, LLC submits that there are extraordinary circumstances warranting a grant of the STA request.

ESPN has contracted 3G Wireless, LLC to provide wireless camera systems to operate within the Major League Baseball stadiums throughout the continental United States for their Sunday and Monday Night Baseball telecasts. Due to the extreme frequency congestion throughout the United States, coupled with the added congestion from traditional Television and News coverage of area events, 3G Wireless requests the use of these channels.

3G Wireless, LLC certifies that the operation of the requested channel for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA for 2267MHz and 2287MHz would serve the public interest by enabling 3G Wireless, LLC to supply the requested remote camera systems for television coverage. The proposed service would enhance coverage of the events by providing on the spot pictures and camera control from mobile locations that would not otherwise be available to the production company.
