To Operate in the 1435-1525MHz, 2200-2290MHz and 2360-2390MHz Telemetry Bands to Provide TV Coverage in and around the Lodi, California area.

3G Wireless, LLC hereby requests Special Temporary Authority (STA) to operate in the 1435-1525MHz, 2200-2290MHz, and the 2360-2390MHz Telemetry Bands pursuant to Section 21.25 of the Commission's Rules. 3G Wireless, LLC requests that the Commission grant it special temporary authority to operate on the frequencies centered on 1456MHz, 1476MHz, 1496MHz, and 1516MHz with a 16 MHz bandwidth, 2206MHz, 2218MHz, 2230MHz, 2242MHz and 2254MHz with a 8MHz bandwidth and lastly, 2367MHz and 2384MHz with a 14MHz bandwidth from May 09, 2015 to May 18, 2015 with intermittent usage. As explained below, 3G Wireless, LLC is filing an STA request for the live television transmission of "The Tour of California" road bicycle race. 3G Wireless submits that there are extraordinary circumstances warranting a grant of the STA request.

NBC Sports has contracted 3G Wireless, LLC to provide the necessary microwave for the live transmission of this eight stage event. Due to the extreme frequency congestion in the Northern California area, coupled with the added congestion from traditional Television and News coverage of the special event, 3G Wireless, LLC requests the use of channels in the 1435-1525MHz, 2200-2290MHz and the 2360-2390MHz Telemetry Bands. A complete map of the race stages can be found on the Tour of California web-site, <http://amgentourofcalifornia.com/stages>.

3G Wireless, LLC certifies that the operation of the requested channels for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA in the 1.4GHz band, 2.2GHz band and the 2.3GHz band would serve the public interest by enabling 3G Wireless, LLC to supply the requested remote video coverage for this event. The proposed service would enhance coverage of the event by providing on the spot pictures from mobile locations along the race route that would not otherwise be available to the production company. 3G Wireless, LLC is in the process of obtaining the consent of the relevant frequency coordinators for this project, including AFTRCC. AFTRCC has indicated its intent to forward the results of the coordination to the Commission.
