3G Wireless, LLC hereby requests Special Temporary Authority (STA) to operate at 1392.5 MHz pursuant to Section 21.25 of the Commission's Rules. 3G Wireless, LLC requests that the Commission grant it temporary authority to operate on the frequencies centered at 1392.5 MHz with a 5 MHz bandwidth and 2276MHz with a 16MHz bandwidth from January 02 through May 02, 2015 with intermittent usage. As explained below, 3G Wireless, LLC is filing an STA request to perform the testing associated with a new camera telemetry system. 3G Wireless, LLC submits that there are extraordinary circumstances warranting a grant of the STA request.

The purpose for the experimental license is to perform ongoing testing of both camera telemetry and return video applications as they relate to video services. Due to the extreme frequency congestion throughout the United States, coupled with the added congestion from traditional Television and News coverage of area events, 3G Wireless requests the use of these channels.

3G Wireless, LLC certifies that the operation of the requested channel for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA for 1392.5 MHz and 2276MHz would serve the public interest by enabling 3G Wireless, LLC to supply the requested remote camera telemetry test. The proposed service would enhance coverage of the events by providing on the spot pictures and camera control from mobile locations that would not otherwise be available to the production company.
