- (3) Operation is NOT PERMITTED using the frequency 2200-2290 MHz.
- (4) The applicant must obtain consents from the Advance Wireless Service licensees prior to accessing to 2170-2178 MHz, 2180-2188 MHz and 2190-2198 MHz bands.

Special Conditions:

- (5) The applicant must obtain consents from the Educational Broadband Service licensees prior to operation in 2500-2508 MHz, 2510-2518 MHz and 2520-2528 MHz bands.
