Special Conditions:

- (3) This frequency assignment in one of the bands 1435-1525 and 2360-2395 MHz was coordinated prior to authorization with the Area Frequency Coordinator (AFC), who also coordinated it, as appropriate, with Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the AFC, as necessary to ensure compatibility with existing uses.
- (4) Operations are non-interference basis to Flight Test telemetry and Air Force Spectrum Dependent System.
