Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. - (3) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
 - WCS (2305-2320 MHz/2345-2360 MHz) licensee (AT&T)
- (4) Prior to commencing any operations in Aeronautical and Fixed frequencies (2360-2395 MHz), the applicant must coordinate with the Aerospace and Flight Test Radio Coordinating Council (AFTRCC).
