Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) GPS re-radiators are limited to a maximum EIRP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft from the building where the test is being conducted. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.

Special Conditions:

- (4) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (5) Licensee shall maintain testing according to the NTIA requirements of section 8.3.27.
- (6) The designated point of contact to terminate the systems if interference occurs is Robby Pinckney at 478-918-5154.
- (7) Licensee shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (8) The test equipment shall only be used indoors and shall be under the control of the applicant.
