Unclassified information (e.g. private, controlled unclassified, or proprietary information) significant to national security	Inestimable Damage <ul style="list-style-type: none"> <li>• Unlimited access to and control over unclassified information, which may include private, proprietary or other controlled unclassified information when there is the potential to cause inestimable damage to national security</li> </ul>
