As explained in our 7/24 message below, this message is to confirm that all of the transmissions addressed in the grant document are currently occurring exclusively within an anechoic chamber with the radiating device contained in the chamber and the doors sealed, with the chamber providing at least 50 dB attenuation.

Accordingly:

- FAA coordination is not required based on current operations, because Special Condition 12 confirms that such coordination is not required when operations are fully within a sealed chamber that is consistent with current operations:

"(12) Operations will occur in a fully shielded anechoic chamber with the door closed, providing at least 50 dB attenuation. Any future operations with the chamber door open or outside the chamber will require a new coordination with FAA."

Based on the above, it is requested that the Commission proceed with processing of this modification application.

In connection with the above-referenced inquiries issued by the ELS requesting AFTRCC and FAA coordination for the pending modification application of Station WE2XBV under File No. 0132-EX-CM-2020, this is to confirm that all of the transmissions addressed in the grant document are currently occurring exclusively within an anechoic chamber with the radiating device contained in the chamber and the doors sealed, with the chamber providing at least 50 dB attenuation.

Accordingly:

- Ref. 56090 - AFTRCC coordination is not required based on current operations, because Special Condition 14 confirms that such coordination is not required when operations are fully within a sealed chamber that is consistent with current operations:

"(14) AFTRCC is not required for operations conducted within an Anechoic Chamber as long as the device radiating can be contained in the chamber and the doors sealed."

- Ref. 56091 – FAA coordination is not required based on current operations, because Special Condition 12 confirms that such coordination is not required when operations are fully within a sealed chamber that is consistent with current operations:

"(12) Operations will occur in a fully shielded anechoic chamber with the door closed, providing at least 50 dB attenuation. Any future operations with the chamber door open or outside the chamber will require a new coordination with FAA."
