Thank you for your E-Mail of 1 March 2017 providing information regarding

the BAE Systems Information and Electronic Systems Integration Inc. ("BAE") six (6) month programs of radio experimentation proposed in pending FCC Experimental Special Temporary Authority Application File Nos. 0147-EX-ST-2017 and 0148-EX-ST-2017 (the "Applications").

Based on our review of the information provided in the Applications, ORBCOMM has no objection to grant of the Applications to permit BAE to conduct its proposed programs of experimentation, as specifically proposed in the Applications, with all radio frequency utilization relating thereto to be on a non-protected non-interference basis in accordance with Part 5 of the FCC's Rules.

However, please be advised that ORBCOMM's above-stated consent is specific to BAE's temporary non-interference FCC Part 5 experimental use of spectrum proposed in the Applications, and such consent shall in no way be construed as ORBCOMM's consent to coordination of spectrum utilization by BAE, or any other party, under any other authorization application or authorization regime.

ORBCOMM has no other comments or objections to the Applications at this time.
