Mr. Sinha,

Thank you for alerting BAE Systems to the issue with the frequency coordination we had requested. I have reviewed your suggested alternate frequencies against our operating parameters and can accept your proposal.

BAE Systems will prepare and submit an application to modify the license for Call Sign WF2XRY to replace the following 2 frequencies per your suggestion:

- 1040.350 MHz – request replacement with 1039 MHz
- 1195.095 MHz – request replacement with 1192 MHz

As you have stated, there is no issue with coordination for 3000 MHz.

Will it be possible for you to provide the NG T #'s for the coordination of 1039 MHz, 1192 MHz, and 3000 MHz?

Thanks again for giving BAE Systems the notification of a conflict and for providing suggested alternatives. If you need any further information from me, please do not hesitate to contact me.
