1510.0/1520.0 under AFTRCC ICN 1618-21/9077 (BSI STA/Broadcast Event-Times Square/NYC, NY) with the following limitations and restrictions:

1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports Intl operations.

- 2) Unprotected NIB operations are under an MO station class.
- 3) STOP BUZZER POC provided with cell and land line contact information that can cease any and all Broadcast Sports Intl emissions if EMI is detected.
