MIDLANTAFC does not object to the use of the lower L-S band channel usage (Frequencies: (MHz) 1439.0/1447.0/1455.0/1463.0/1471.0/1479.0/1487.0/1495.0/1503.0/1511.0/1519.0/2364.0/2372.0/2380.0 under AFTRCC ICN 1631-21/9085 (BSI STA/PGA Event-Sea Island, GA) with the following limitations and restrictions:

- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to Broadcast Sports Intl operations.
- 2) Unprotected NIB operations are under an MO station class.

3) STOP BUZZER POC provided with cell and land line contact information that can cease any and all Broadcast Sports Intl emissions if EMI is detected.
