Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This special temporary authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control by the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Dear Mr. Wright:

COMSAT Corporation, by its COMSAT World Systems business unit ("COMSAT"), herein requests a grant of Special Temporary Authority from March 13, 1995 thorough September 12, 1995 to enable it to provide Intelsat C-band space segment capacity in the Pacific Ocean Region ("POR") via the Intelsat satellite at 180° E. to seagoing vessels of the U.S. Navy. In support of its request, COMSAT submits the following information.

COMSAT has been requested to provide service by a U.S. carrier that intends to provide Intelsat C-band communications via the 180° E. satellite to a U.S. Navy ship operating in the POR. COMSAT will provide Intelsat space segment capacity beginning March 13, 1995 consistent with its current wideband mobile experimental authorization (KA2XHN) and the Special Conditions listed therein. COMSAT intends to shortly file an application to amend its pending KA2XHN renewal application to
