- 1) Non-interference basis to all Flight Test telemetry missions and no protection afforded to CP Communications, LLC operations.
- 2) Unprotected NIB operations are under an XT or MO station class.
- 3) STOP BUZZER POC provided with cell and land line contact information that can cease any and all CP Communications, LLC emissions if EMI is detected.
