RE: Letter of Concurrence for Experimental License

Dear Mr. Alderfer:

On behalf of Fixed Wireless Holdings, LLC, American Teleecasting of Denver, LLC, Clearwire Spectrum Holdings III, LLC and Clearwire Spectrum Holdings III, LLC, wholly owned subsidiaries of Clearwire Corporation, an indirect subsidiary of Sprint Corporation ("Clearwire"), Clearwire hereby provides this letter of concurrence, with conditions, to CableLabs("CableLabs"), for an Experimental Radio Service license to be filed with the Federal Communications Commission for approval. CableLabs requires the authorization to run a test procedure involving the co-existence of LTE-LAA and WiFi networks with a small cell that uses Band 7 and better understand the performance impact on both networks when operating on the same or adjacent channels. Current testing plans are in the CableLabs indoor test house located at 14652 Beeler Street, Brighton, Colorado starting in mid-May 2015 through March 31, 2016.

Clearwire's concurrence is conditioned to only a certain portion of the 2.5 GHz band, and for indoor use only. Specifically, Clearwire concurs to the indoor use of 2548.5-2558.5 (channels C3, D1 and D2) and 2668.5-2678.5 MHz (channels H3 and G1) at the authorized location in Brighton, Colorado. Clearwire does not concur to any outdoor testing, due to concerns of harmful interference to Clearwire operations in close proximity to this Brighton location.

Clearwire is the long term *de facto* lessee of call signs WHR521 (C3), WHR488 (D1 and D2) and WHR7800 (G1), and the BRS licensee of call sign B110 (H3) which covers 2548.5-2558.5 MHz and

2668.5-2678.5 MHz for the proposed testing and demonstration in Brighton, Colorado. Additional conditions:

- Clearwire reserves the right to revoke this consent with seven (7) days prior notice to CableLabs.
- CableLabs agrees that in the event of any interference, within four (4) hours of oral or written notification, it will immediately cease any use of the subject spectrum
