Mr. Kennedy -

By this e-mail, Caterpillar requests that you change the requested radius for testing in the above-referenced STA and regular experimental authorizations from 100 kilometers to 5 (five) kilometers. There was obviously some confusion regarding the question on the form.

As noted below, we understand if it is not possible at this stage to withdraw the frequency coordination notices. Even if that cannot be done, Caterpillar still wants to change the requested radius for testing as noted above.

If possible, Caterpillar requests that you withdraw or suspend the frequency coordination requests you sent out yesterday for the two applications noted above. We now realize that there was confusion in completing the application and specifically the requested radius for conducting the EMC testing.
