Hi Doug,

We now have information to complete this application. I will provide updated exhibits for the application for the following, if this all sounds right to you:

1. Launch August 1 -15, License needed by July 1.
2. Name changed to 1HOPSAT-TD instead of 1HOPSAT-1.
3. Ground station will have a 3m dish as backup to the 4.5m dish already applied. This will affect the ground station license as well.
4. Actual C band bandwidth smaller than stated previously; changing it to 20 MHz up and down. Affects Spacecap and application.
5. Other numbers adjusted as needed.

Please let me know if it sounds ok to proceed with these, and any thoughts on other actions needed, and I will get them all in today. Sorry these changes come relatively late, the operator has been searching / negotiating for a ride until now.
