¹ This filing is a re-submission of a prior request under File #0252-EX-CM-2019 which was dismissed without prejudice on December 17, 2019 for an inadvertent failure to respond to an FCC request for information issued November 14, 2019 (Ref. #51861).

² This authorization was held by Harris Corporation prior to the Harris & L3 merger. All FCC authorizations involving L3 entities were transferred to Harris Corporation as part of that transaction. Upon consummation of the Harris & L3 transaction, the licensee name for the FCC authorizations held directly by Harris Corporation was changed to L3Harris Technologies, Inc. With regards to the experimental authorization licensee name changes, a letter was filed with the Commission on July 29, 2019 advising of the name change from Harris Corporation to L3Harris Technologies, Inc. Owing to an administrative oversight, call sign WI2XNV was inadvertently not listed on Attachment A of that name change request. L3Harris respectfully requests that the licensee name be updated to conform with its other experimental authorizations directly held by L3Harris Technologies
