Ladies and Gentlemen:

Hughes Electronics Corporation d/b/a Hughes Network Systems ("Hughes") hereby requests an extension of the Experimental Special Temporary Authorization ("STA") by which Hughes is conducting testing and link measurements of prototype satellite equipment at its San Diego, California facility. Hughes requests the extension for an additional 180 days through and including June 6, 2002.

On December 8, 2000, the Commission granted Hughes an STA (FCC File No. 0537-EX-ST-2000) for a period of 180 days through and including June 8, 2001. The STA authorized Hughes to perform testing and link measurements of prototype satellite equipment intended for export, with the technical parameters described in the STA. The Commission granted an extension of the STA on June 8, 2001 (FCC File No. 0227-EX-ST-2001) for another period of 180 days through and including December 8, 2001.

Pursuant to the STA, Hughes conducts over-the-air testing of a handheld terminal for the Thuraya Satellite System. The over-the-air capability permits Hughes to test the phone as it will be used in an actual environment. Hughes performs system verification tests of the end-to-end operation of the phone, including the man-machine interface ("MMI"), beam selection, idle mode behavior, high penetration alerting, and voice quality.

Grant of the extension of this STA will serve the public interest by facilitating Hughes' continued ability to confirm the operation of the Thuraya handheld terminal as it will be used in an over-the-air handheld environment. The extension also will permit Hughes to validate upcoming releases for development completion and for MMI enhancements.
