Dear Jose, Nadja, Thomas and Robin:

Hispanic Information and Telecommunications Network. Inc. ("HITN") is the licensee of EBS Station WLX370, Channels C1234. Station WLX370 is subject to a grandfathered lease with Pixed Wireless Holdings, LLC ("PWH"), a wholly-owned subsidiary of Clearwire Corporation ("Clearwire"). Clark County School District ("CCSD") is the licensee of EBS Station WNC851, Channels A1234. Station WNC851 is subject to a FCC approved De Facto Transfer Lease with NSAC, LLC ("NSAC"), a wholly-owned subsidiary of Clearwire (FCC Lease Identifier L000003491. Intel Corporation has requested that HITN, FWH, CCSD, NSAC, CSHII and Clearwire (the Consenting Parties") consent to Intel's temporary use of Channels A1, A2, A3, B1, B2, and B3¹ in conjunction with the demonstration of Intel equipment to take place at two separate events in Las Vegas:

¹ The Spectrum for which consent is being given in this letter includes the following frequencies: A1 (002502.00000-002507.50000 MHz), A2 (002507.50000-002513.00000 MHz); A3 (002513.00000-002518.50000 MHz), B1 (002518.50000-002524.00000 MHz); B2 (002524.00000-002529.50000 MHz) and B3 (002529.50000-002535.00000 MHz). The FCC mandated transition has been completed for both stations, and the Transition Completion Notice has been filed, but the post transition minor modification applications have not yet been filed.

- the Consumer Electronic Show from January 4 through January 10, 2009 at the Las Vegas Convention Center in Las Vegas and
- an Intel Sales and Marketing Conference from January 17 through January 23, 2009 at the Las Vegas Venetian Hotel / Convention Center Hotel in Las Vegas.

By your respective signatures below, each of the Consenting Parties each hereby consent to lotel's use of the Spectrum on a temporary basis for the above-described indoor equipment demonstration purposes. Intel agrees to operate on the Spectrum in accordance with the rules and regulations of the Federal Communications Commission, and to take all necessary steps to cause no interference to any current operations and to protect and preserve the status of the Licenses and Leases associated with WLX370 and WNC851. Intel further agree to indemnify the Consenting Parties against any damages caused by their temporary operation of the Spectrum, including, without limitation, the payment of any fines levied by the FCC or other regulatory authority for any improper use of the Spectrum, such as interference with other channels. Without limiting the foregoing, Intel agrees to provide the Consenting Parties with a local contact person and telephone number during the trade show who can be immediately reached in the event of interference, and to immediately cease any use of the Spectrum upon request of any of the Consenting Parties, until any interference issues that might arise are resolved to your satisfaction.
