For the reasons set forth below, Zeus Holdings Limited ("Zeus") and Intelsat, Ltd. ("Intelsat") (together, the "Applicants"), by their counsel, hereby request an Erratum to correct the December 22, 2204 *Order and Authorization* in the above captioned proceeding, which granted the Applications.

- 1. Appendix A of the *Order and Authorization* contains a typographical error. The call sign "KA58" associated with File Number SES-T/C-20040903-01328 should be "KA258."
- 2. Paragraph 42 of the *Order and Authorization* states:

Applicants request that grant of the Applications include authority for Zeus, upon consummation of the proposed transaction, to acquire control of the following authorizations and filings: (1) all authorizations issued or assigned to Intelsat or any of its subsidiaries subsequent to the filing of the Applications but prior to consummation of the proposed transfers (the "Interim Period"); (2) all

We conclude that any authorizations issued during the pendency of this proceeding, any licenses that have been constructed and are operational by the time the transfer is consummated, and any applications pending at the time of consummation should be deemed to be covered by this Order and Authorization to the extent that they are listed in Appendix A.
