RE: ATSC 3.0 Field Tests on Channel 9, WJW Cleveland, Ohio

Dear Mr. Wallace:

Further to your request seeking the Canadian Broadcasting Corporation's (CBC) concurrence for an ATSC 3.0 trail on Channel 9, WJW Cleveland Ohio given the potential for interference to CBC owned station CBET-DT Windsor, Ontario on Channel 9, the following outlines the conditions for CBC acceptance of potential interference to CBET-DT:

- 1. Notice to be given to CBC one week in advance of trial start date.
- 2. CBC to be provided a contact at all times during the trial period.
- 3. No testing on October 19th, 2015 due to Canadian federal election.
- 4. No testing during prime time hours defined as 17:00 to 23:00 ET daily.
- 5. CBC agreement is valid until March 31, 2016. If the trail is to continue past that date, a new approval from CBC is required.
- 6. In the event of suspected interference to CBET-DT Windsor, the following will apply:
- 6.1 MSW will fully co-operate with CBC in evaluating the interference including providing any test equipment or receivers required to undertake said evaluation.
- 6.2 If in CBC's sole evaluation, as it applies on Canadian soil, that there is a material impact on CBET-DT, tests will be limited to night time testing between 01:00 to 05:00 ET.
- 6.3 If in CBC's sole evaluation, night testing is problematic, CBC reserves the right to request a reduction in power of the test transmitter and/or a change in antenna pattern.





6.4 CBC reserves the right to request a cessation to the trail if 6.1 to 6.3 fail to resolve any interference concerns.
