You will have to select spot (discrete) frequencies in the 464.5-468.5 MHz frequency band that you have requested, exclude the band or select a non-government exclusive band as opposed to this shared government band. If these options are not possible, then please justify in detail the need to use approximately 500 channels of 7.6 kHz bandwidth within 464.5-468.5 MHz.

Greetings, Mr. Trevino.

I have your e-mail of November 14, 2007 concerning the above-referenced STA. (Please note, however, that I did not receive such a message on October 17, when you apparently first sent an e-mail about this; I am not certain why I did not receive it).

I will amend this STA if absolutely necessary to list spot frequencies instead of the band limits. However, the National Football League has been obtaining identical STAs for the past ten years or so,

most of them filed by me, and we have never been asked to do this before. The problem is that within this unused television channel, we have specified 5 MHz, within which we will use different channel centers depending on which bandwidth is used for the different emissions. Also, the way your STA electronic filing is set up, I would have to enter each channel center and each emission, using occupied bandwidths of 6.25, 12.5, and 25 kHz over a 5 MHz band segment, which is an awful lot of data entry, and would take many hours to do.

As I say, I will do it if there is no other alternative, but please note the following file numbers, which show how this has been done in the past, showing only the upper and lower limits of the band edges and the emission designator. There is continuous, real-time frequency coordination of these frequencies on site, long before the event and until after the event by the NFL's Game Day Coordinators, and compatible sharing of the band segment by all users is virtually guaranteed through that means.
