Dear Ms. Dortch:

Nextel Communications, Inc. ("Nextel") and Sprint Corporation ("Sprint") jointly filed Transfer of Control of Licenses and Authorizations on February 8, 2005.¹ The Experimental Radio Service applications listed below were among multiple applications filed seeking Commission approval for the transfer of control to Sprint of the approximately 40,000 licenses and authorizations held both directly and indirectly by Nextel.
