On December 9, 1998, your office processed a Form 405 (Application for Renewal of Radio Station License in Specified Services) submitted by Orbital Sciences Corporation ("OSC") for renewal of the radio stations necessary to the operation of the Orbital SeaStar™ satellite program. *See* Attachment. Your office, however, rejected this application for processing because, instead of having two (2) separate \$45.00 dollar fees for the two CallSign Numbers/Licenses enumerated on the form, the application had only one (1) \$45.00 dollar check.


