I went into amend/complete the application, administrative tab, but I cannot find a field to change the confidentiality selection. Also, I could not find a way to change the confidentiality of the "confidential treatment justification" exhibit. Can you help me resolve these two issues?

However, we do not want the "Experiment Description" revealed for public viewing before we can redact significant sections of it. Therefore if that exhibit will end up revealed, we ask first that it be removed from the application and we will submit a replacement with certain information redacted. If the above changes to confidentiality will only reveal the STA application form with the details of the transmissions, that will be fine.
