To Operate in the 1425 -1530MHz Telemetry  
Band to Provide Television Coverage in New Orleans, Louisiana.

RF Film, Inc. hereby requests Special Temporary Authority (STA) to operate in the 1425 - 1530Mhz telemetry band pursuant to Section 21.25 of the Commission's Rules. RF Film, Inc. requests that the Commission grant it temporary authority to operate on the frequency centered on 1515MHz with a 16 MHz bandwidth from May 16, 2013 with intermittent usage and ceasing operation on July 12, 2013. As explained below, RF Film, Inc. is filing an STA request for the shooting of a 20<sup>th</sup> Century Fox feature film currently titled "Planet of the Apes 2" shooting in New Orleans, Louisiana. RF Film, Inc. submits that there are extraordinary circumstances warranting a grant of the STA request.

Fox Louisiana Production, LLC has contracted RF Film, Inc. to provide the necessary microwave for the filming of this movie. Due to the extreme frequency congestion in the New Orleans, Louisiana area, coupled with the added congestion from traditional Television and News coverage of the special event, RF Film requests the use of channels in the 1425 - 1530MHz Telemetry Band.

RF Film, Inc. certifies that the operation of the requested channel for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA in the 1.4GHz band would serve the public interest by enabling RF Film, Inc to supply the requested remote video coverage for this event. The proposed service would enhance filming of the event by providing on the spot pictures from mobile locations that would not otherwise be available to the production company. RF Film, Inc. is in the process of obtaining the consent of the relevant frequency coordinators for this project, including AFTRCC.
