To Operate in the 2200 -2290MHz Telemetry
Band to Provide Television Coverage in Yuba City, California.

RF Film, Inc. hereby requests Special Temporary Authority (STA) to operate in the 2200-2290Mhz telemetry band pursuant to Section 21.25 of the Commission's Rules. RF Film, Inc. requests that the Commission grant it temporary authority to operate on the frequency centered at 2210MHz with an 8 MHz bandwidth from December 12, 2014 with intermittent usage and ceasing operation on December 20, 2014. As explained below, RF Film, Inc. is filing an STA request for the shooting of a DreamWorks Studios feature film currently titled "The James Donovan Story" shooting at Beale Air Force Base in Yuba City, California. RF Film, Inc. submits that there are extraordinary circumstances warranting a grant of the STA request.

Saint James Productions, LLC has contracted RF Film, Inc. to provide the necessary microwave for the filming of this movie. Due to the extreme frequency congestion in the Yuba City area, coupled with the added congestion from traditional Television and News coverage of the special event, RF Film requests the use of channels in the 2200 - 2290 MHz Telemetry Band.

RF Film, Inc. certifies that the operation of the requested channel for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA in the 2.2GHz band would serve the public interest by enabling RF Film, Inc to supply the requested remote video coverage for this event. The proposed service would enhance filming of the event by providing on the spot pictures from mobile locations that would not otherwise be available to the production company.
