To operate in the 2360 - 2390 MHz Telemetry Band to provide Film coverage for Netflix Productions LLC. 150 Thorn Hill Rd. Suite A, Warrendale PA. 15086.

RF Film, Inc. hereby requests Special Temporary Authority (STA) to operate in the 2360 - 2390 MHz telemetry band, pursuant to Section 21.25 of the Commission's Rules. RF Film, Inc. requests that the Commission grant it temporary authority to operate on the frequency centered on **2368MHz with an 8MHz bandwidth from November 19, 2019 with intermittent usage and ceasing operation on December 18, 2019**. As explained below, RF Film, Inc. is filing an STA request for the shooting of a **Netflix Films Production at PNC Park Pittsburgh PA**. RF Film, Inc. submits that there are extraordinary circumstances warranting a grant of the STA request.

Classic Films Inc. has contracted RF Film, Inc. to provide the necessary microwave link for the Aerial Video. Due to the extreme frequency congestion in the downtown Pittsburgh PA area, coupled with the added congestion from traditional Television and News coverage of special events in the area, RF Film requests the use of a channel in the 2360-2390MHz Telemetry Band.

RF Film, Inc. certifies that the operation of the requested channel for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA in the 2.3GHz band would serve the public interest by enabling RF Film, Inc. to supply the requested remote video coverage for this event. The proposed service would enhance filming of the event by providing on the spot pictures from mobile locations that would not otherwise be available to the production company. RF Film, Inc., is in the process of obtaining the consent of the relevant frequency coordinators for this project, including AFTRCC. AFTRCC has indicated its intent to forward the results of the coordination to the Commission.
