Raytheon Company (Missiles & Defense – M) Experimental STA Application Request for Confidentiality Application File Number: 1037-EX-ST-2021

Raytheon Company (Missiles & Defense – M) is requesting confidentiality for the exhibits filed in support of experimental license application file number 1037-EX-ST-2021, to the extent allowed by the Commission's Rules, 47 C.F.R. 0.459. Should the Commission be unable to grant this confidentiality request, the applicant requests that the Commission contact the applicant as soon as possible.

The radio operations proposed under this application are for the testing of advanced radio technologies incorporated into Raytheon's products and for research and development and on behalf of Raytheon's customers in the Department of Defense. While the Commission's Rules automatically protect some national security information from public disclosure under 47 C.F.R. §0.457, the application submitted here does not fit into the specific provisions of Section 0.457. Therefore, Raytheon is seeking to protect the information submitted here under the provisions of Section 0.459 of the Commission's Rules. The request for confidentiality is intended to protect proprietary and sensitive information about how some of the features in Raytheon's products are developed. Protecting this information will protect the DOD and Raytheon's proprietary technology from unwarranted exposure.

Additionally, the exhibit to the filing includes some technical information which Raytheon wishes to keep secret from foreign entities that may be searching the FCC's public filings, in addition to shielding the sensitive information from general release. The details in the exhibit include information that could lead others to learn how some of the missile systems achieve their performance. Keeping the design and operation of those tests confidential is key to maintaining the totality of the trade secrets related to Raytheon's products and how they work.

This request for confidentiality requests that the Commission withhold from public view any information related to the exhibits filed with this application. Protection of this information is essential to preserve Raytheon's ability to fulfill its responsibilities to its Department of Defense customers and to protect the American public.

In accordance with the OET Electronic filing system requirements, a point by point explanation of the request under section 0.459 of the Commission's Rules is set forth below. Raytheon hereby requests confidential treatment of this application and, in particular, confidential treatment of the exhibits including link budgets and technical data.
