

## DESCRIPTION OF TRANSACTION AND PUBLIC INTEREST STATEMENT

Through several related applications, Raytheon Company (“**Raytheon**” or “**Transferor**”) and United Technologies Corporation (“**UTC**” or “**Transferee**”) respectfully request the consent of the Federal Communications Commission (“**FCC**” or “**Commission**”) for the transfer of control of licenses from Raytheon to UTC<sup>1</sup> in connection with the parties’ proposed merger. As stated below, the proposed merger will serve the public interest, convenience, and necessity, and the parties respectfully request that the Commission expeditiously grant such applications.

### I. THE PARTIES

Raytheon Company (NYSE: RTN), incorporated in Delaware and headquartered in Waltham, Massachusetts, is a technology and innovation leader specializing in defense, civil government and cybersecurity solutions. Raytheon provides state-of-the-art electronics, mission systems integration, C5I® products and services, sensing, effects, and mission support for customers in more than 80 countries. Raytheon has four business segments: Integrated Defense Systems; Intelligence, Information & Services; Missile Systems; and Space & Airborne Systems.

United Technologies Corporation (NYSE: UTX), incorporated in Delaware and headquartered in Farmington, Connecticut, provides high-technology products and services to the aerospace and commercial building industries worldwide. UTC has four business segments: Otis; Carrier; Pratt & Whitney; and Collins Aerospace Systems. Otis and Carrier serve customers in the commercial, government, infrastructure and residential property sectors, and refrigeration and transport sectors worldwide. Pratt & Whitney and Collins Aerospace Systems primarily serve commercial and government customers in both the original equipment and aftermarket parts and services markets of the aerospace industry.

### II. DESCRIPTION OF TRANSACTION

On June 9, 2019, Raytheon, UTC, and Light Merger Sub Corp. (a wholly owned subsidiary of UTC) entered into an Agreement and Plan of Merger in which Raytheon and UTC will combine in an all-stock merger.<sup>2</sup> At the completion of the merger, Light Merger Sub Corp. will merge with and into Raytheon, with Raytheon surviving the merger and becoming a wholly owned subsidiary of UTC. Raytheon Company will be delisted and deregistered from the New York Stock Exchange, but will remain in existence under its present Delaware incorporation. Immediately following consummation, United Technologies Corporation will change its name to “Raytheon Technologies Corporation” and its stock symbol to “RTX.” It is estimated that immediately following the merger, former Raytheon stockholders will own approximately 43% of Raytheon

Technologies Corporation shares and pre-merger UTC stockholders will own approximately 57% of said shares. It is anticipated that the merger will close in the second quarter of 2020. Please see Attachment A for a simplified diagram of the proposed merger structure.

### III. RAYTHEON LICENSES AND PENDING APPLICATIONS

Raytheon presently has licenses and pending applications as shown in the table below and listed in the relevant attachments:

Raytheon's wireless licenses support the day-to-day operations of its business as an aerospace and defense company, including personal radios, aircraft radios, electronic tolling systems, and microwave links. Experimental licenses support the development and testing of various products including radars, air traffic control systems, and secure communications systems. No licenses are associated with any auctioned spectrum, nor used to provide services to the public for a fee.

Raytheon will remain in existence and will continue to be the licensee under said licenses following the merger. Control of the licenses will be transferred to the top-level parent company, Raytheon Technologies Corporation (f/k/a United Technologies Corporation prior to the merger).

### IV. PUBLIC INTEREST STATEMENT

The parties respectfully request that the Commission grant the applications because the proposed transaction will serve the public interest. Section 310(d) of the Communications Act of 1934, as amended ("**Communications Act**"), states that no transfer of control may take place except upon a finding by the Commission that the public interest, convenience and necessity will be served thereby."<sup>3</sup> In making this determination, the Commission must first assess whether the proposed transaction complies with the specific provisions of the Communications Act, other applicable statutes, and the Commission's rules.<sup>4</sup> If the proposed transaction does not violate a statute or rule, then the Commission considers whether the transaction could adversely impact the public interest by substantially frustrating or impairing the objectives or implementation of the Act or related statutes.<sup>5</sup>

As a threshold matter, Raytheon and UTC have the requisite “citizenship, character, financial, technical, and other qualifications” to hold Commission licenses.<sup>6</sup> Both parties are U.S. corporations and have strong financial performance records, with Raytheon reporting \$27B and UTC reporting \$66.5B in 2018 net sales. Raytheon and UTC presently hold several Commission licenses and have the legal and technical expertise to ensure compliance with Commission regulations.

Consenting to the transfer of control of licenses will serve the public interest, convenience, and necessity by enabling Raytheon Technologies Corporation to continue to utilize radiofrequency spectrum for its operations and product development. The combined company will offer expanded technology and development capabilities to deliver innovative and cost-effective solutions aligned with customer priorities and the national defense strategies of the U.S. and its allies. Since the licenses will be used solely for the private operations and development efforts of Raytheon Technologies Corporation, there will be no adverse impact to competitive communications services regulated by the Commission.<sup>7</sup>

#### **V. OMITTED, PENDING, AND AFTER-ACQUIRED LICENSES**

Raytheon and UTC request that Commission approvals of the transfer of control applications also include (i) any applications or licenses that were inadvertently omitted from the transfer applications and (ii) any applications or licenses filed or granted during the pendency of the transfer applications and prior to the notification of consummation of the merger. This request is consistent with Commission practice.<sup>8</sup>

#### **VI. CONCLUSION**

For the foregoing reasons, Raytheon and UTC respectfully request that the Commission grant the applications for transfer of control.

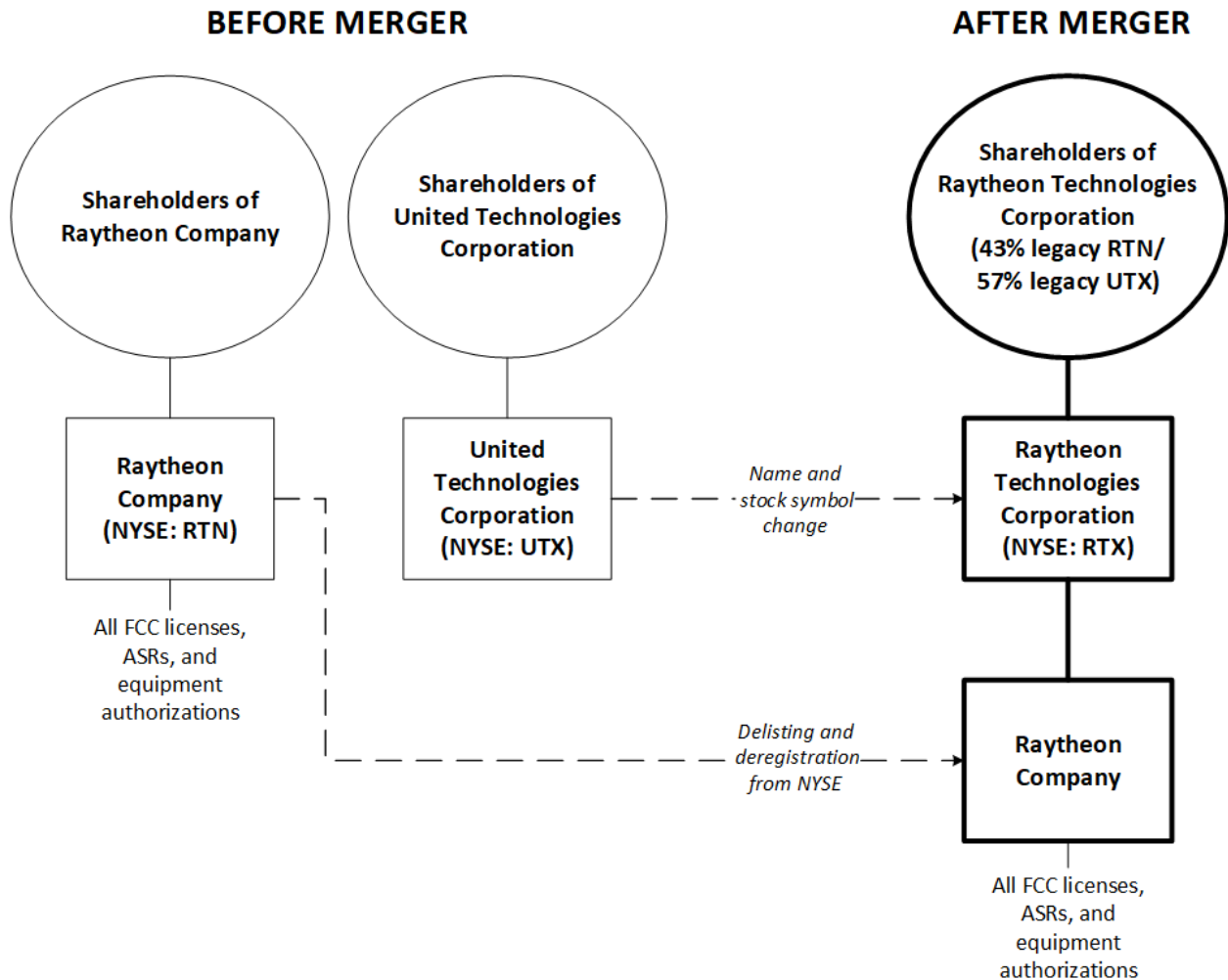
