In accordance with sections 1.65 of the Commission's rules and in accordance with the practice and procedure specified by the Office of Engineering and Technology on its website, <https://fjallfoss.fcc.gov/oetcf/els/misc/FccElsFAQ.cfm>, we are writing to the Office of Engineering and Technology to request that the Commission's records be updated to properly reflect the name and address of the entity that holds the referenced licenses.
