Rockwell Collins is renewing an experimental license WD2XJA with the FCC.

The FCC has requested that we contact you for prior-coordination and to obtain a consent letter, from your organization, (email is acceptable), for our use of frequency bands: 476-482 MHz, 488-494 MHz, and 752-794 MHz. The location of frequency use will be at latitude and longitude: N32-59-45.0/W96-39-48.0 (Richardson, TX) and mobile (within 10 km), centered around N32-59-45.0/W96-39-48.0.

The FCC will not proceed without SBE's consent. Any assistance you can provide would be greatly appreciated.
