Sceye must schedule their operations, with the DoD-AFC (WSMR), at least 96 hours prior to activation, via e-mail to [usarmy.wsmr.imcom-central.list.dodafc@mail.mil](mailto:usarmy.wsmr.imcom-central.list.dodafc@mail.mil). Sceye must provide notional flight path showing any DoD restricted airspaces.

If Sceye is supporting a DoD initiative, then they will provide a DoD Contract Number. AFC-WSMR will support overflight of DoD restricted airspaces, provided the vendor schedules the use of this airspace, with the requisite Range POC or Sponsor.

If Sceye is NOT supporting a DoD initiative, then they will avoid overflight of DoD restricted airspaces.

Operations are strictly on a non-interference basis, to DoD, and other Federal, licensed, users.
