RE: Letter of Concurrence & Consent for Screened Images, Inc. Pilot in Leakesville, Mississippi File. No. 0488-EX-PL-2013

Dear Sir or Madam:

Pursuant to Part 5 of the rules of the Federal Communications Commission ("Commission"), 47 C.F.R. Part 5, AT&T Mobility, LLC, on behalf of its wholly-owned subsidiary New Cingular Wireless, LLC (collectively "AT&T") hereby submits this letter of concurrence with the associated application for an experimental Special Temporary Authorization ("STA") in the Leakesville, Mississippi area, filed by Screened Images, Inc. (Screened). Screened seeks to demonstrate the feasibility of their managed access mobile radio communication system, in a 'real-world' environment from 08/13/2013 to 7/1/2015 pursuant to grant of this experimental STA by the Commission.

Screened Images' application requests to operate on frequencies associated with 4 licenses within a 0.9 km radius of a specified center point in Leakesville, MS (31 10 35N and 88 36 29W). The licenses are:

WPUE309 **B5** 1964.8MHZ (BCCH 685)

Screened Images requests to use these channels for its demonstrations. Screened Images is working cooperatively with AT&T, has agreed to coordinate the demonstrations of its technology with AT&T, and will avoid harmful interference while conducting the demonstrations. In addition, Screened Images has agreed to immediately cease operations should any interference issues arise during the demonstrations.

AT&T desires to consent Screened Images' testing of its technology and, therefore, agrees to permit Screened to use the referenced channels within 0.9 km of Leakesville, MS (31 10 35N and 88 36 29W) for a period of 5/01/2013 up to 9/1/2013 after the grant of the associated application. In authorizing Screened Images to use AT&T's licensed

spectrum in this manner, AT&T accepts responsibility for any failure of an actual subscriber communications which may occur in the area in which Screened Images is authorized to operate during the course of its operations under the requested experimental STA. Accordingly, AT&T supports the grant of the associated application for an experimental STA.
