Pursuant to Part 5 of the rules of the Federal Communications Commission ("Commission"), 47 C.F.R. Part 5, Sprint Corporation, on behalf of its wholly-owned subsidiaries WirelessCo, L.P. and Nextel License Holdings 4, Inc. (collectively "Sprint") hereby submits this letter of concurrence with the associated application File Number ~~0746~~-EX-ST-2014 for an experimental Special Temporary Authorization ("STA") in the Pendleton, Indiana area, filed by ShawnTech Communications, Inc. ("ShawnTech"). ShawnTech seeks to demonstrate the feasibility of their proprietary technology, Correctional Cellular Communication Call Control System, C5 Contraband Assessment/LAMS, in a "real-world" environment until March 19, 2015 after grant of this experimental STA by the Commission.


ShawnTech's application requests to operate on PCS Broadband frequencies within a 0.69 km radius of a specified center point in Pendleton, IN (39-59-00.3 N / 085-45-37.7 W). Sprint is the licensee of PCS Broadband license WPOK609, authorized to operate on the C Block channels (1895-1910/1975-1990 MHz) in the Pendleton, IN area. Sprint is also the licensee of SMR licenses WPLM741, authorized to operate on the B Block channels (817-818/862-863 MHz), and WPLM742, authorized to operate on the X Block channels (818-824/863-869 MHz), in the same Pendleton, IN area. ShawnTech requests to use, *inter alia*, PCS C Block channels and SMR B and X Block channels for its demonstrations. ShawnTech is working cooperatively with Sprint, has agreed to coordinate the demonstrations of its technology with Sprint, and will avoid harmful interference while conducting the demonstrations. In addition, ShawnTech has agreed to immediately cease operations should any interference issues arise during the demonstrations.

Sprint desires to support ShawnTech's testing of its technology and, therefore, agrees to permit ShawnTech to use the PCS channel 1075 (1903.75/1983.75 MHz) and B and X Block CDMA channel 476 (817.9000/862.9000 MHz) within 0.69 km of Pendleton, IN (39-59-00.3 N / 085-45-37.7 W) for a period until March 19, 2015 after the grant of the associated application. Accordingly, Sprint supports the grant of the associated ShawnTech application for an experimental STA to operate its Correctional Cellular Communications Call Control System, C5 Contraband Assessment/LAMS for a period up to March 19, 2015. Sprint has received a copy of the instant application.
