Silvus Technologies, Inc., hereby requests Special Temporary Authority (STA) to operate within the 2360-2390MHz telemetry band pursuant to Section 21.25 of the Commission's Rules. Silvus Technologies, Inc. requests that the Commission grant it temporary authority to operate on the frequency centered at 2380MHz with a 20MHz bandwidth from October 24, 2021, through October 31, 2021, with intermittent usage. As explained below, Silvus Technologies, Inc., is filing an STA request to demonstrate new microwave technologies in a MIMO/MANET configuration for a demonstration for developing a new Sales Team's technical background. Silvus Technologies, Inc., submits that there are extraordinary circumstances warranting a grant of the STA request.

Silvus Technologies, Inc., is demonstrating new microwave emission technologies for the new Sales Team as it relates to data coherency, propagation, data throughput, vehicle integration and impact. Due to the extreme frequency congestion in the Palm Springs, California area, coupled with the added congestion from traditional Television and News coverage of area events, Silvus Technologies, Inc., requests the use of these channels.

Silvus Technologies, Inc., certifies that the operation of the requested channels for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA for the 2.3GHz band would serve the public interest by enabling Silvus Technologies, Inc., to educate and demonstrate the reliability of their emission scheme as it relates in an aerial exercise in a wireless MIMO/MANET configuration. The proposed service would enable demonstration of the Streamcaster SC4480 transceiver / antenna array in a terrestrial exercise.
