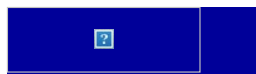
If this is an option that you would kindly allow me, I will be happy to file for a new STA license for 6 months with such a letter attached to the application.

Your favorable response is welcomed.

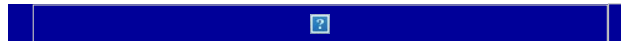
