The purpose of this experimental operation is to conduct video production activities in support of a sailing regatta. The instant application proposes STA operation for a United Kingdom video and audio production and broadcasting company. A virtually identical STA was granted for this event in January of 2016 with the exception of substitution this year of the 2 GHz BAS band for the 7 GHz BAS band. See, WJ9XIZ, File No. 1343-EX-ST-2015. No interference was reported last year at this identical regatta.

The applicant is the host broadcaster for the 2017 ISAF Sailing World Cup Miami, a televised sailing regatta that is part of the 2017 international ISAF Sailing World Cup Regatta. In the United States, this event will take place in Biscayne Bay, Florida, between January 26, 2017 through and including January 29, 2017. Video production activities will be controlled from the U.S. Sailing Center in Miami at 2476 South Bayshore Drive in Coconut Grove, Florida 33133.

The application proposes the use of commercial RF cameras located on chase boats in Biscayne Bay in the range of 2 GHz; relay signals in the 2 GHz broadcast auxiliary band for relay of video signals to the land based broadcast compound, and UHF radio talkback base and mobiles in the band 450-470 MHz.

All of the RF devices will be under the control of Sunset Vine Productions at all times. This authorization is requested for the express purpose of conducting video production operations described in the application and herein. There will be no other use of this authorization in any other manner or for any other purpose. The facilities proposed will not be operated after the expiration date of the STA. The total number of RF video production devices and UHF base and portable transceivers shall not exceed 40. Sunset Vine Productions will be responsible for ensuring that the devices are used only in authorized location and only in the manner authorized. Sunset Vine Productions is aware that other stations may be licensed on these frequencies and if any interference occurs, the facilities will be subject to immediate shut down and operation will not recommence unless and until the interference is resolved to the satisfaction of all licensees.

All use of the 7 GHz BAS band will be coordinated in advance with the SBE market frequency coordinator, and channels in the 450-470 MHz band will be selected so as to avoid ULS assignments in the area and by prior monitoring of channels to avoid those in use. No public safety channels will be utilized at all.
