Special Conditions:

- (3) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3300-3800 MHz band.
- (4) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas.
- (5) Operation is subject to prior coordination with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to commencing the demonstration operation.
- (6) Licensee be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
- (7) Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (8) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
