Hi Carl,

We have decided to amend the application for file number 0020-EX-PI-2004 (call sign WD2XHT). I believe that Rodolfo Munoz spoke to you about this some time back.

I tried a couple links on the OET efile page but couldn't find the right link to request/submit an amendment to the application.

There are several changes that we would like to make. First is to change the location of the station from Lawrenceville, GA to Jefferson, GA.

The second is to reduce the number of frequencies requested from thirteen to five and to reduce output power from 10 mW to 1 uW with a corresponding reduction in associated ERP.

How shall I proceed with the request for the amendment? Is it sufficient to use the Submit Correspondence link or is there another method, or even simply email?
