Thank you for your response - nice to hear from you again and I hope you are doing well.

1. We have amended the STA request for a SoS of mid-July.
2. For my own edification, we placed in comments that the remote terminal would be operated aboard an aircraft, based in Tampa but flying along the 2 dB/k line of the XTAR-LANT-C7 footprint. Because it will be radiating from anywhere within this large footprint, we tried to explain its location in comments rather than provide any fixed location in the STA application. How do we best capture the location of a mobile remote terminal in this request?
