Special Conditions:

- (1) Transmissions in the 14.2-14.4 GHz band are authorized in the air-to-ground direction only.
- (2) Emissions to within 10 degrees of the Geostationary Orbit are limited to a Maximum EIRP density of -30 dBW in any 4 kHz band (i.e. -30 dBW/4 kHz)
- (3) No transmissions are authorized in the ground-to-air direction using the 11.7-12.2 GHz band.
- (4) This STA may be terminated or modified at the FCC's discretion, without a hearing, if conditions warrant
- (5) No renewals of this experimental STA will be permitted
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by FAA Contract Number DTFAWA-05-C-00093. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
