- (5) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (6) Prior to operation, licensee must coordinate with the existing and future licensed users in the area of operation to avoid interference.
- (7) Power and emission must conform to Parts 22, 24, and 90 of the Commission's rules.
