This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) Amdocs, Inc. must notch out the following:
3550-3650MHz band due to frequency band is in designated exclusion zone defined in Fast Track Report (NTIA Technical Report TR-15-517: 3.5 GHz Exclusion Zone Analyses and Methodology) and no Environmental Sensing Capability (ESC) equipment.
- (2) Amdocs, Inc shall maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (3) Amdocs, Inc shall consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas prior to operation in this band.
- (4) Amdocs, Inc shall be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.
