This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee shall maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (4) Licensee shall consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas prior to operation in this band.
- (5) Amdocs, Inc. may not operate in the 3550-3650 MHz band. Amdocs, Inc. should be aware that the requested locations fall within the Exclusion Zone defined in the NTIA Fast Track Report (NTIA Technical Report TR-15-517: 3.5 GHz Exclusion Zone Analyses and Methodology).
- (6) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (7) Licensee shall ensure that the transmitting station antenna(s) main beam gain tip down when possible and avoid pointing above the horizon to protect satellite stations
- (8) All the experimental devices will be under the control of Amdocs, Inc.
