The FAA Spectrum Engineering Services has completed the review of your Frequency Coordination Request.

TRK 210034 is assigned an FAA Coordination number NG T210024 that indicates FAA's coordination that may or may not include operational limits/conditions as part of the requirement for FAA concurrence. The FAA Spectrum Engineering Services has provided the following comments:

COMMENTS: FAA COORDINATION OF RTCA-COMPLIANT C-BAND RADIOS (COLLINS CNPC-5000E) FOR UAS C2 OPERATIONS. ORIGINAL REQUESTS WAS MODIFIED TO MATE CENTER FREQUENCIES WITH THE TUNING STANDARDS REQUIRED BY THE C2 MOPS. HENCE, 5035 MHZ WAS CHANGED TO 5035.2050

Please note that this concurrence does not constitute authority to transmit. Your authority to transmit must be obtained from the FCC.

Please provide this concurrence notice to the FCC as part of your frequency application, to demonstrate completion of the FAA coordination process. The FAA Coordination number is only valid until 6/15/2021; if you need an extension, please submit an inquiry via WebFCR .

The attached file contains a Card 3 format with all technical and operational parameters; operations are required to be contained within these parameters for the FAA's concurrence to remain valid. If any of these parameters change, the license to transmit shall be re-coordinated with the FAA and updated with the FCC.
