Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) Licensee must maintain operation separation from the grandfathered earth stations as defined in Part 90, sub-part Z, or coordinate and agreement with the grandfathered earth station licensees.
- (3) Licensee must ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed areas.
- (4) Operations in the Fletcher, N.C. location, (NL 35-26-06; WL 82-32-15) is limited to indoors ONLY for the 3600-3800 MHz frequency band.
- (5) The maximum antenna altitude for all transmitters in the three locations (above ground level) is 10 feet set forth by applicant.

Special Conditions:

- (6) At least 5 business days prior to operating, American Tower Indoor DAS LLC, must notify licensees of earth stations operating in-band and adjacent band above 3700 MHz within 15 kilometers of the locations from which experimental operations will occur. American Tower Indoor DAS LLC, must also provide such notification to the National Spectrum Managers Association frequency coordinators by email. (see http://wireless.fcc.gov/services/index.htm?job=licensing_1&id=microwave). The notice must include the name and contact information of the stop buzzer personnel that will be available to cease operations in the event of reported interference. The notification should include the testing parameters (specific location(s), antenna gain(s), antenna pattern, antenna height(s), antenna orientation, eirp density) and day and times of each test. Consult the IBFS database to identify licensed earth station above 3700 MHz band.
- (7) All of the experimental devices will be under the control of American Tower Indoor DAS LLC.

- (9) No automatic renewal for operations in the 3700-3800 MHz frequency band of this authorization. Requests for renewal of operations in the 3700-3800 MHz frequency band may be subject to further review.
